7	<p><b><u>Financial Matters</u></b></p> <p>7.1 Approval of Accounts 2024-2025</p> <p>A copy of the accounts was shared at the meeting. SF explained a discrepancy of £10 which related to an underpayment of this figure to the Clerk which would be corrected.</p> <p>The accounts were approved on this basis.</p> <p>7.2 <b>Annual Return – annual governance</b></p> <p>The Committee discussed each point on the annual return concerning governance and confirmed that appropriate arrangements had been put in place for 20224-25. The exemption certificate was agreed upon as the income/turnover was well within the £25k limit. The variances between current year and previous year could be explained. It was agreed that a contingency for the website needed to be kept as Cllr JT had researched that costs could be between £220 and £929/annum should a change of host be required.</p> <p>7.3 <b>Appointment of Internal Auditor</b></p> <p>The committee agreed that CF should approach Chris Goodchild as internal auditor.</p>
